FIRST AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS FOR GALLERY 23 EAST

THIS FIRST AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS ("Amended Declaration") is made effective on this 13th day of June, 2019, by Gallery 23 East, LLC, a Nebraska limited liability company, or its successors and assigns ("Declarant").

WHEREAS, Declarant wishes to amend Sections 6.2, 15.3 and the Exhibits of that certain Declaration Of Covenants, Conditions, Restrictions And Easements For Gallery 23 East, recorded as Document Number 201902476 in the Register of Deeds of Dodge County, Nebraska (the "Original Declaration"), recorded on or about June 3, 2019; and

WHEREAS, Declarant is authorized under Section 15.4 of the Original Declaration to grant additional permanent easements for drainage; and

WHEREAS, terms not otherwise defined in this Amended Declaration shall have the meanings as set forth in the Original Declaration.

NOW, THEREFORE, Declarant amends the Original Declaration as follows:

- 1. <u>Reservation of Easements</u>. Section 6.2 is hereby amended with the following text prior to the first sentence of this section in the Original Declaration: "In addition to the easements granted in Article XV,...".
- 2. <u>Drainage and Lift Station Easements</u>. Section 15.3 is hereby deleted and replaced with the following language:

Lots 4, 5, 6, 16, 17, 21, 22, 26, and 27, all located in Block 6, inclusive, all in Gallery 23 East, a subdivision located in part of the NW1/4 of Section 17, Township 17, Range 9 east of the 6th P.M. in Dodge County, Nebraska, are each subject to a ten foot (10') wide permanent easement reserved to the Declarant, during the period of Declarant Control, and to the Association thereafter, in, on, over, under, and across each such lot to facilitate any and all drainage from Lake Galleria and its adjacent Lots, streets, and Common Areas to ditches adjacent to Gallery 23 East (the "Drainage Easement"), as set forth on Exhibits B, C, D, E, F, G, H, and I, and attached hereto and incorporated herein by

reference. The Drainage Easement further restricts the Owners of Lots 4, 5, 6, 16, 17, 21, 22, 26, and 27, all located in Block 6, from altering the slope or fill level of such Lots, and prohibits the construction or placement of structures, landscaping, trees, or any other kind of obstruction within the Drainage Easement. Declarant, during the period of Declarant Control, and the Association thereafter, reserves the right to alter the scope of the Drainage Easement on the Lots described in this section 15.3 in accordance with the Gallery 23 East Surface Water Drainage Plan and any amendments thereto. Lots 27 and 28 of Block 6 are each subject to additional easements reserved to the Declarant, during the period of Declarant Control, and to the Association thereafter, in, on, over, under, and across each such lot to facilitate the installation, replacement, repair and operation of a sanitary sewer lift station.

3. <u>Miscellaneous</u>. Except as specifically set forth in this Amended Declaration, all terms and conditions of the Original Declaration shall remain in full force and effect. This Amended Declaration shall inure to the benefit of and be binding upon the parties hereto and their respective successors and assigns. The rights granted hereunder shall run with the land and burden the Property. This Amended Declaration shall be construed under and in accordance with the laws of the State of Nebraska, without regard to principles of conflicts of law.
